Matters Arising from the Meeting of the 21st January 2021

PKF Littlejohn – any update on whether we can use another auditor. It seems that we are going to have to keep with PKF, (this is their last year).

Mr Leary asked the Clerk to check back on the response from PKF to his email.

The Clerk will write to PKF to gain exact guidance regarding the dates for the public rights for the 20/21 AGAR.

Mr Leary confirmed that the Parish Council needed to adopt the unaudited accounts as 31st March 2021 and this was the time to raise any queries/questions. Nothing was forthcoming, so the accounts were adopted.

VAT – The payment of £9962.39 had been paid into the bank that day, (15/4/2021). There had been a delay following the initial submission in December 2020. The request was reinput on the 12th of March 2021 after following up with the HMRC. The funds had been received in the new tax year but there was little we could do about that.

Grass Cutting funds from Via – The Clerk reported that she had been in touch with Frank Fearn of Via in relation to putting in our invoice. Mr Fearn had explained that the invoice would need to be submitted in September/October this year. (Last year I submitted the invoice in June and received payment in July). The Parish Council asked the Clerk to check that this was indeed correct by going back to Mr Fearn.
